Color Coding Meanings

No Highlighting: recommending a YES vote **to retain** the Judge.

Yellow Highlighting: The Judge retiring or not running for office for some reason. Will **NOT** retain.

GENERAL INFORMATION

[Appellate](#) court judges as well as [superior](#) court judges in [Maricopa](#), [Pima](#), and [Pinal](#) counties stand for [retention](#).^[2]

Retention election

In counties with populations greater than 250,000—[Maricopa](#), [Pima](#), and [Pinal](#) counties—[superior court](#) judges are chosen through a merit selection system. In these counties, judges are appointed by the governor with the help of a selection commission.

At the end of their term, the judges remain in office through uncontested [retention elections](#) every four years.^{[1][2]}

Counties with populations less than 250,000 have the option to adopt the merit selection process through ballot initiative.^[2]

State Supreme Courts

Each state within the [United States](#), plus the [District of Columbia](#), has at least one **supreme court**, or **court of last resort**. [Oklahoma](#) and [Texas](#) both have two courts of last resort, one for civil appeals and one for criminal appeals.

The supreme courts hear appeals of the decisions made in the lower [trial](#) or [appellate](#) courts. The number of justices on each court varies between five and nine. The length of a justice's term can be as short as six years or a lifetime appointment.

In eight states, the partisanship of the courts is explicitly labeled as a result of partisan elections. Democrats control three of these states, and Republicans control five. The remaining 42 states do not have explicitly partisan courts. Ballotpedia uses three methods to determine a state court's partisan balance:

1. How many justices were registered members of a political party;
2. The partisan affiliation of the governor who appointed each justice
3. If those methods didn't work, we survey media coverage of the court and its decisions to determine partisan leanings

Overview of state supreme courts

There are **346** justices across all 52 state supreme courts, including Oklahoma and Texas' courts of criminal appeals. Each state has a different method for appointing justices and a different length of their terms. Each court also has a different partisan makeup.

The following areas of interest will show various differences of supreme courts among states:

1. The area "List of courts" lists each state's court of last resort and information about how many justices sit on the court, how a justice is selected, how long their term is, if there's a retirement age, and what the court's partisan control is.
2. The area "Partisan makeup" breaks down which courts have explicitly partisan ones, and visualizes what the make up of the courts were after the 2024 elections based on Ballotpedia's criteria in determining partisanship.

Selection methods

States may have different methods of selection depending on whether it is for a full-term or to complete an unfinished term. On re-election, justices may be re-elected in a different type of election from the initial type they were elected under. The following tabs break down the differences in selection methods, with reference to when a justice is appointed.

- The "Selection methods (full-term)" shows how each state selects a justice for a complete term, such as when a justice is appointed to replace a retiring justice, or a regularly scheduled election is held.
- The "Selection methods (to fill vacancies)" shows how each state selects a justice to complete a term when a vacancy happens at an irregular interval.
- The "Re-election methods" shows how each state renews a justice's term once the initial term ends.
- Arizona is done through [Gubernatorial appointment with legislative confirmation](#): The governor picks the justice, with legislative approval. AZ is one of 22 states using this method of selecting Judges.

Judicial selection in Arizona

1. **Arizona Supreme Court**

Qualifications

To serve on this court, a justice:^[6]

- “
- Must be admitted to the practice of law in Arizona and be a resident of Arizona for the 10 years immediately before taking office;
 - May not practice law while a member of the judiciary;
 - May not hold any other political office or public employment;
 - May not hold office in any political party;
 - May not campaign, except for him/herself; and,
 - Must retire at age 70.^[7]

Chief justice

The court's [chief justice](#) is selected by peer vote. He or she serves in that capacity for five years.^[8]

If a midterm vacancy occurs on the court, the seat is filled as it normally would be if the vacancy occurred at the end of a justice's term. Potential justices submit applications to the [Arizona Commission on Appellate Court Appointments](#), and once the commission has chosen a slate of nominees, the [governor](#) picks one from that list. After occupying the seat for two years, the newly appointed justice stands for [retention](#) in the next general election. The justice then serves a full six-year term if he or she is retained by voters.^[9]

2. Arizona Court of Appeals

The 28 judges of the [Arizona Court of Appeals](#) are appointed by the governor from a list of names compiled by the [Arizona Commission on Appellate Court Appointments](#). The commission is composed of 16 members who serve staggered four-year terms. The membership includes 10 non-attorneys, five attorneys, and the chief justice of the supreme court, who chairs the commission.^[10]

The initial term of a new judge is at least two years, after which the judge stands for [retention](#) in an uncontested yes-no election. Subsequent terms last six years.^[11] For more information on these retention elections, visit the [Arizona judicial elections](#).

The court of appeals is divided into two divisions. Nineteen judges are in Division One and are based in [Phoenix, Arizona](#). The other nine judges are in Division Two and are based in [Tucson, Arizona](#).^[12]

Qualifications

To serve on this court, a judge must be:

- a state resident;
- licensed to practice law in Arizona for at least five years;

- of good moral character; and, at least 30 years old and under the age of 70 (retirement by 70 is [mandatory](#)).^[12]

Chief judge

The [chief judge](#) of each division is selected by a peer vote. He or she serves in that capacity for one year.^[13]

Vacancies

If a midterm vacancy occurs on the court, the seat is filled as it normally would be if the vacancy occurred at the end of a judge's term. Potential judges submit applications to the [Arizona Commission on Appellate Court Appointments](#), and once the commission has chosen a slate of nominees, the [governor](#) picks one from that list. After occupying the seat for two years, the newly appointed judge stands for [retention](#) in the next general election. The judge then serves a full six-year term if he or she is retained by voters.^[14]

3. Superior Courts *See also:* [Arizona Superior Courts](#)



Judges of the [Arizona Superior Court](#) are selected in one of two ways:

- Counties with a population exceeding 250,000, judges are appointed by the governor from a list of names compiled by the [Arizona Commission on Appellate Court Appointments](#).
 - [Coconino](#), [Pima](#), [Pinal](#), and [Maricopa](#) counties use this method. The state constitution provides for other counties to adopt merit selection through a ballot initiative, which [Coconino County](#) did in 2018.^[15]
 - After an appointment, judges serve for two years and then must run in a yes-no [retention election](#) in the next general election. If retained, judges will go on to serve a four-year term.^{[16][17]}
- If a vacancy occurs in the middle of a judge's term in a county with a population of less than 250,000, the governor appoints a judicial candidate to serve until the next general election. The winner of the nonpartisan election will serve the remainder of the unexpired term. If a vacancy occurs at the end of a judge's term, the vacancy will be filled through a nonpartisan election and the winner will serve a four-year term.^[18]

Presiding judge

A presiding judge is chosen by the supreme court for each superior court that has two or more superior court judges.^[16]

4. Limited jurisdiction courts

Arizona has two types of limited jurisdiction court(s):

justice courts and municipal courts.

A. Arizona Justice Courts

Judges of the Arizona Justice Courts are each elected to four-year terms. The elections for this court are partisan contested elections. To serve on this court, a judge must be a registered voter in Arizona, a resident of the justice court precinct, and able to read and write English. A law degree is not required.^[19]

B. Arizona Municipal Courts

Judges of the Arizona Municipal Courts are appointed to terms of varying lengths by the governing body of their municipality, except in Yuma, Arizona. In Yuma, judges on these courts are elected.^[20]
